The competition will be held in accordance with the provisions of the RFHE Trec 2024 Regulations, FITE Regulations, the General, Veterinary and Disciplinary Regulations approved by the RFHE.

For the classification of the **Euskadi Championship**, only riders with a National or Autonomous Competitor License issued by FVH qualify, all of them in their corresponding categories (Absolute 3*. JJ 2*. Junior 1*. 0*).

OPEN TEST AUTHORIZED DEPARTURES BY DUO

- Riders are required to carry a medical card on their person during the POR, in a visible location. This card will include their relevant medical history, vaccinations, allergies, medications, and blood type.

Note: Each rider will inform the Organizing Committee of two telephone numbers to contact in case of an accident.

Minors are required to present the corresponding parental authorization.

The use of a back protection vest is mandatory for PTV.

Horses

- Sports Validation Book or Sports Validation Card or Book of Horse Identification Card (LIC) issued by the RFHE or a valid FEI passport. NAC/INTER
- Equine influenza vaccine within the six-month period. For all tests officers
- Origin and Health Guide or TME, for both horses from within the community and outside. For all official tests.
- Valid Annual Horse License (LAC). For all official events.
- The transportation costs of the horses are the responsibility of the participating teams.
- It is mandatory to have the horse in the enclosure during the competition days, either in its accommodation or in the spaces indicated by the organization.
- The CO will make paddocks available to riders for participating horses.
- All horse owners and competitors are responsible for damages that may be caused by themselves, their employees and their horses.

Insurance

All riders and/or owners of participating horses are personally responsible for any damages caused to third parties by themselves, their employees, their horses, and their transportation. Therefore, it is recommended that riders purchase insurance to cover this liability during their stay at the center during the competition.

SPECIAL CONDITIONS

All participants, by simply registering, accept the rules and conditions of the Contest, as well as any changes made by the Organizing Committee.

Both the schedules and the track on which the tests are carried out may be altered by the Organizing Committee based on the number of participants or other external factors.

All horses must present the "Identification Book" upon arrival at the facilities.

Horses," with their corresponding vaccinations noted. Horses without current vaccinations will **NOT** be admitted to the competition and will lose their registration and boarding rights.

ACCEPTANCES AND WAIVER

All participants accept the rules and conditions of the competition, including any changes made by the Organizing Committee, including schedules and the order of events based on the number of participants. All participants have been notified and are required to have civil liability, accident, and illness insurance, and the Organizing Committee is not liable for any irregularities in said insurance.

The owners and riders of horses housed in stalls or paddocks are solely responsible for their location, the horses' behavior, supervision, safekeeping, and any damage they may cause to facilities, animals, and/or people. The owners are also solely responsible for the safekeeping and custody of their equipment.
